This is a Safety Plan between Buckinghamshire Council, Ms Test in respect of Child A

Date of Plan: 19.08.2022

Purpose of Safety Plan

The purpose of this safety plan is to make explicit the concerns the Local Authority has regarding A and what we expect you to do as a consequence. We want to work with you to achieve the best possible solutions to your situation and to safeguard A from harm. This agreement is intended to cover the period whilst Ms Test and A reside with Maternal Grandparents and until the conclusion of court proceedings.

Mother, Ms Test, agrees to:

- Ms Test agrees to work openly and honestly with professionals. She will not have any contact with Mr Risk, directly or indirectly, of any sort including any form of social media.
- Ms Test agrees to immediately report any incidences of domestic abuse/violence to the Police and Local Authority.
- A will not have any unsupervised contact with Mr Risk, any family time will need to be arranged and supervised by the Local Authority.
- Ms Test agrees to inform the Local Authority and Police of any attempts made by Mr Risk to contact her or any chance encounters.
- Ms Test will engage with visits undertaken by the Local Authority, both announced and unannounced.
- A will live at the home of the Maternal Grandparents and will not be left in the care of any other persons without the prior consent of the Local Authority and a PNC check by the Police.

- A will not be left unsupervised in the sole care of his mother, Ms Test, and will be supervised by the Maternal Grandparents or another adult agreed by the Local Authority in advance.
- Ms Test agrees to refrain from using any illicit drugs. This includes, but is not limited to cannabis, cocaine and prescription medication not prescribed to Ms Test.
- Ms Test agrees to refrain from drinking alcohol whilst A is in her care.
- Ms Test is required to immediately phone the police should Mr Risk attend the Maternal Grandparent's home.
- Ms Test is to inform the Local Authority and her solicitor of any changes of mobile phone numbers and any phone number that Mr Risk attempts to contact her on or any number that she attempts to contact Mr Risk on.

Buckinghamshire Council agrees to:

- Social Worker to visit the Maternal Grandparents and advise them of what constitutes supervised contact.
- Social Worker to visit the Maternal Grandparents and advise the Maternal Grandparents of the extent of the communication between Ms Test and Mr Risk so they are fully informed of the risks.
- Provide a child minder in the event there is no person suitable to supervise A
 during the grandparent's working hours. Ms Hunt and Maternal Grandparents
 to advise the Local Authority at least 3 days prior to such occasions to provide
 the Local Authority with sufficient notice to arrange a child minder.

Views of the Child

A is too young to verbalise his views regarding the safety plan however it is expected that he would wish to be kept safe from further incidents of domestic violence between his parents and for family time to take place in a safe environment with protective adults helping to keep him safe.

Role of Maternal Grandparents:

- Maternal Grandparents will immediately report any incidences of domestic abuse/violence to the Police and Local Authority.
- Not allow any unsupervised contact between A and Mr Risk, any family time will need to be arranged and supervised by the Local Authority.
- Inform the Local Authority and Police of any attempts made by Mr Risk to contact Ms Test, themselves or A or any chance encounters.
- Engage with visits undertaken by the Local Authority, both announced and unannounced.
- Not allow A to be left in the care of any persons without the prior consent and agreement of the Local Authority and a PNC check by the Police.
- Not allow A to left unsupervised in the sole care of his mother and to ensure that A will be supervised by the Maternal Grandparents or another adult agreed by the Local Authority in advance.
- Maternal Grandparents to inform the Local Authority, with 3 days notice, of any dates where they are unable to supervise Ms Test and A.
- To immediately phone the police should Mr Risk attend their home.

review the arrangements for A to ensure that he is safe.

and Maternal Grandparents will be included in any review and we will listen to your

views and wishes which will be taken into account alongside a review of what has

happened since we made this agreement.
