## Frequency of supervision

Case Supervision generally will be undertaken every month for all children. In some teams it will be agreed with the AD that the AP can supervise these children, however the TM should oversee these cases at least quarterly and record their management oversight.

## **Professional Supervision**

<u>All</u> staff (including managers, SMs, ADs, DCS) should have a 4-weekly reflective supervision session with their manager.
