Do you work with children, young people or parents?

The education, interventions and guidance we offer children and young people can play a key role in supporting them to become successful and resilient adults. As individual organisations, we strive to have an impact with each young person, but it can be difficult to do this alone and we recognise that we are more successful when we work together.

Wiltshire Police's Youth and Early Intervention Development Group, Swindon Borough Council's Family Intervention Support Service, Swindon Safeguarding Partnership are hosting four virtual forums. The aim is to provide professionals with an opportunity to better understand the local services available and the support offered.

Each day there, will a themed session with presentations by guest speakers and there will be signposting to local information and resources. The themes will be:

Monday 24 th May	Adverse childhood experience and trauma
Tuesday 25 th May	Early Help – diversion, intervention and safeguarding
Wednesday 26 th May	Youth violence and exploitation
Thursday 27 th May	Mental health

Supervision Orders Update for safeguarding partners

Reminder: When Children's Services have been granted a Supervision Order at the end of Care Proceedings the plan that is agreed in Court will be integrated into the Child in Need Plan.



For the duration of this Supervision Order the Child in Need policy will be the framework within which the progress and implementation of the plan agreed at Court, will take place. The contribution of partners to improve the outcomes for the child will be reflected in this plan as the child will be considered as a Child in Need.

Foetal Alcohol Spectrum Disorder (FASD)

The Department of Health and Social Care is funding a number of projects and initiatives as part of the Innovation Fund which is focussed on improving the outcomes for the children of alcohol dependent parents.

Swindon Borough Council is one of the 9 project partners, delivering the Restore Project in Swindon. Public Health England have hosted a series of webinars about children of alcohol dependent parents and the most recent one was on Foetal Alcohol Spectrum Disorder (FASD). It featured a range of speakers covering research, projects and the lived experiences of parents with children who have a diagnosis of FASD.

Female Genital Mutilation – Information Sharing (FGM-IS)



What is FGM-IS? A national IT system, which provides healthcare professionals and administrative staff a mechanism to record that a girl (under the age of 18) has a family history of Female Genital Mutilation (FGM). The FGM-IS is part the NHS Spine. Healthcare professionals and administrative staff can view, add and remove the FGM indicator, and it can be accessed via the Summary Care Record Application (SCRa), or with a local clinical system integrated with FGM-IS.

Swindon and Wiltshire Sexual Assault Referral Centre (SARC) has achieved Male Accreditation via Lime Culture





Amy Mitchell SARC Manager has stated that pathways and resources have been put in place, which have been specifically designed to support male survivors. SARC staff have completed training with Survivors UK, which was valuable in helping staff understand the different barriers, and myths surrounding male rape; they are able to address self-blame and male survivors are given a choice of a female or a male crisis worker.

One of the continuing challenges has been to gain valuable feedback from male clients, as often males report the crime years after it has happened so SARC support is not appropriate. We have relied on previous attendees and partner organisations to help us gather this information, and will continue to do so going forwards.

Sibling Sexual Abuse: A knowledge and practice overview



This report considers the complex issues and challenges raised by sibling sexual abuse, and provides findings from research and practice to support professionals in approach. Thought to be three times as common as parental abuse, most professionals are likely to encounter sibling sexual abuse at some stage of their careers. Focussing specifically on the assessment and intervention of sibling sexual abuse, the report promotes a child-first approach, looking at a family holistically and encouraging cross-agency collaboration. Guidance for safeguarding adults in care homes



NICE have published guidance for safeguarding adults in care homes. Access the <u>website</u> or a <u>PDF version</u> of the guidance.
