SCHEME OF DELEGATED DECISION MAKING

Children's Social Care

August 2021

Introduction

This Scheme of Delegation sets out who has the authority to make decisions on behalf of Walsall Council's Social Care. Staff at all levels need to be confident on where they have delegated authority to make decisions and must also be clear on who is the decision maker, where they do not have the permission.

Delegation creates the authority to carry out a task or to make a decision. This in turn places a requirement on those for whom authority has been granted to be accountable and responsible for the decisions they have been asked to make. Anyone who makes a decision must be confident that they know the scope of their authority.
