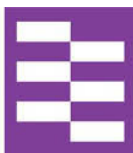

# THE NORTHAMPTONSHIRE PROTOCOL FOR REDUCING THE CRIMINALISATION OF CHILDREN IN CARE AND CARE LEAVERS

## What is it?

An agreement between organisations to work together to:

- Help prevent children and young people who have been in care entering the criminal justice system.
- Understand the needs of those children and young people.
- Make sure those children and young people in the criminal justice system are treated fairly and have the right support.
- Make sure victims of crime are treated fairly and supported.

## Why is this needed?

Research shows that children and young people who have been in care are over-represented in the criminal justice system and more likely to be criminalised for minor incidents (*In Care, Out of Trouble*, Lord Laming 2016).



## WHAT THIS MEANS FOR YOU

- Foster carers and professionals will try to resolve any incidents in-house rather than involving the police.
- If you are involved in an incident, your side of the story will be listened to and you will not be unfairly punished because you have been in care.
- People working with you understand the vulnerabilities that can affect care-experienced young people.
- If you are taken into custody, you will have the support you need to understand what is happening.

## Key points of the protocol

### Responding to incidents

- Non-judgmental recording of incidents.
- Managed in-house where possible.
- Mitigating factors to be taken into account.

### Restorative justice

- Aims to address and repair harm.
- A voluntary and safe process for all.
- Respectful to all parties.
- Facilitated by trained professionals.

### Role of the police

- To be called where the situation cannot be safely managed.
- Custody only used as a last resort.
- Use of discretionary powers such as diversion schemes.

### Young people in custody

- Support provided through the process by professionals such as social workers.
- A package of support in place upon young person's release from custody.
