



# Social Worker User Guide for ePEP Online

## ***Overview***

The ePEP system has been provided to assist education settings, children's social care professionals, carers and others responsible for their education to support CIC to make good progress in education and training. In addition the system provides a mechanism to gather important information and to assist all those involved to meet their statutory duties.

## ***Responsibilities***

As the personal education plan (PEP) is part of a child or young person's care plan, it is a social worker's responsibility to ensure that there is a PEP in place and review meetings occur. If the child or young person is in education or training, organising the meeting must be in collaboration with the education or training provider and the designated teacher (DT) or designated person (DP) within that provider.

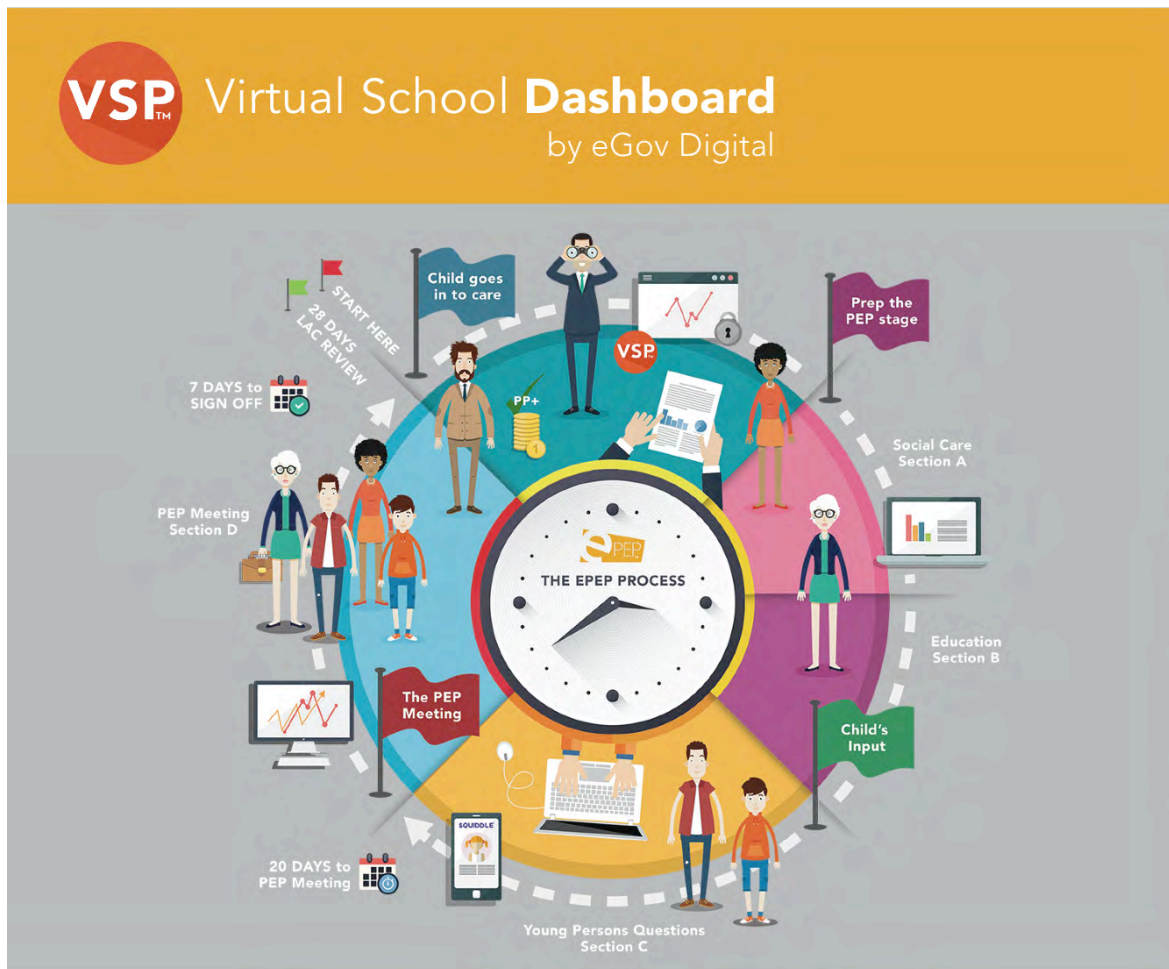
An initial PEP meeting should be initiated within 10 days of a child entering care and **must** be held before the first statutory review, which takes place within 28 days of a child or young person being received in to care irrespective of, whether a child or young person is in education or training.

**If a child or young person is not in education or training, please seek advice from the Virtual School (VS) before the PEP meeting.**

A PEP meeting should be held to review the PEP three times a year, once every academic term (autumn, spring, summer), and if a child or young person in statutory education (reception to year 11) changes education provision.

## The PEP Process

The PEP Process is shown in the diagram below and is broken down into the following sections:




1. A child comes into care and the child's Core Data is added onto the ePEP system.
2. The SW should log into the ePEP system and initiate the PEP for the new LAC. This will send out invites to the attached professionals.
3. The SW completes their Section A of the PEP
4. The DT completes the education information in Section B of the PEP.
5. The Young Person enters their views into Section C
6. The PEP Meeting takes place and the PEP Meeting page within Section B is completed
7. The SW will mark their section as complete
8. The DT will mark their section and the YP section as complete

9. The PEP should be completed and submitted to the VS within 7 days of the PEP Meeting date.
10. LAC review then takes place within 28 days of the child coming into care

### ***Logging in to ePEP***

First of all you need to go to **epeponline.com** on your Web Browser. You must then enter your **email address** and **password** in the relevant boxes on the screen.



If you have forgotten your email address or password then you can use the links provided on the Log In Screen. If you are still having problems accessing the system you will find a Support Contact Number. This is **0345 220 0132**.

## ***ePEP Home Page***

When you have successfully logged into the system, you will be taken to your Home Page. At the top of the Home Page you will find your navigation bar. You can use this to navigate around the ePEP system.

***If you are a user that has a number of Looked After Children from different authorities that are using the ePEP system then you will see all of your children listed on your Home Page.***

Red arrows in the original image point to the 'View' button in the first table and the 'PEP' button in the second table.

Clicking on the 'View' button will take you to that child's Profile Page. Clicking on the 'PEP' button will take you directly into the PEP document.

## Child's Profile Page

The first things you will see are the **Key Indicators** at the top of the page. This shows you basic information about the child in an easy to read format. If you click on the **Pupil Premium Spend** tab this will show you a running target of Pupil Premium that has been approved by the VS for that child.

You will notice that there are some indicators next to the Current PEP. These indicators show who has/hasn't completed their PEP section. The example above shows that both the DT and SW have not completed. Once complete, these boxes will change to green.

After the PEPs, you have space to add **User Notes**. You may write here anything you feel is relevant to the child's information. The notes can be added through the **Actions** table. In the Actions table, you can also upload photographs or documents and also view Key Stage Results.

There is also a visual representation of the child's attendance record, which shows you their current attendance percentage, and a graph of all attendance entries.

## Creating a PEP

If a child does not have a PEP on the system then it is the responsibility of the Social Worker to set this up. In order to create a PEP, please go to the Current Formal PEP box on the child's Profile Page. You will see an '**Add**' button.

The child's key Stage and Year Group will be automatically populated. The date initiated will default to the date the PEP is being created. The target date for completion will automatically adjust to 7 days after the PEP Meeting date.

If you are happy that all of the details are correct, click 'Create PEP'. You will be taken to the child's overview screen where you will see a green 'Successful!' bar.

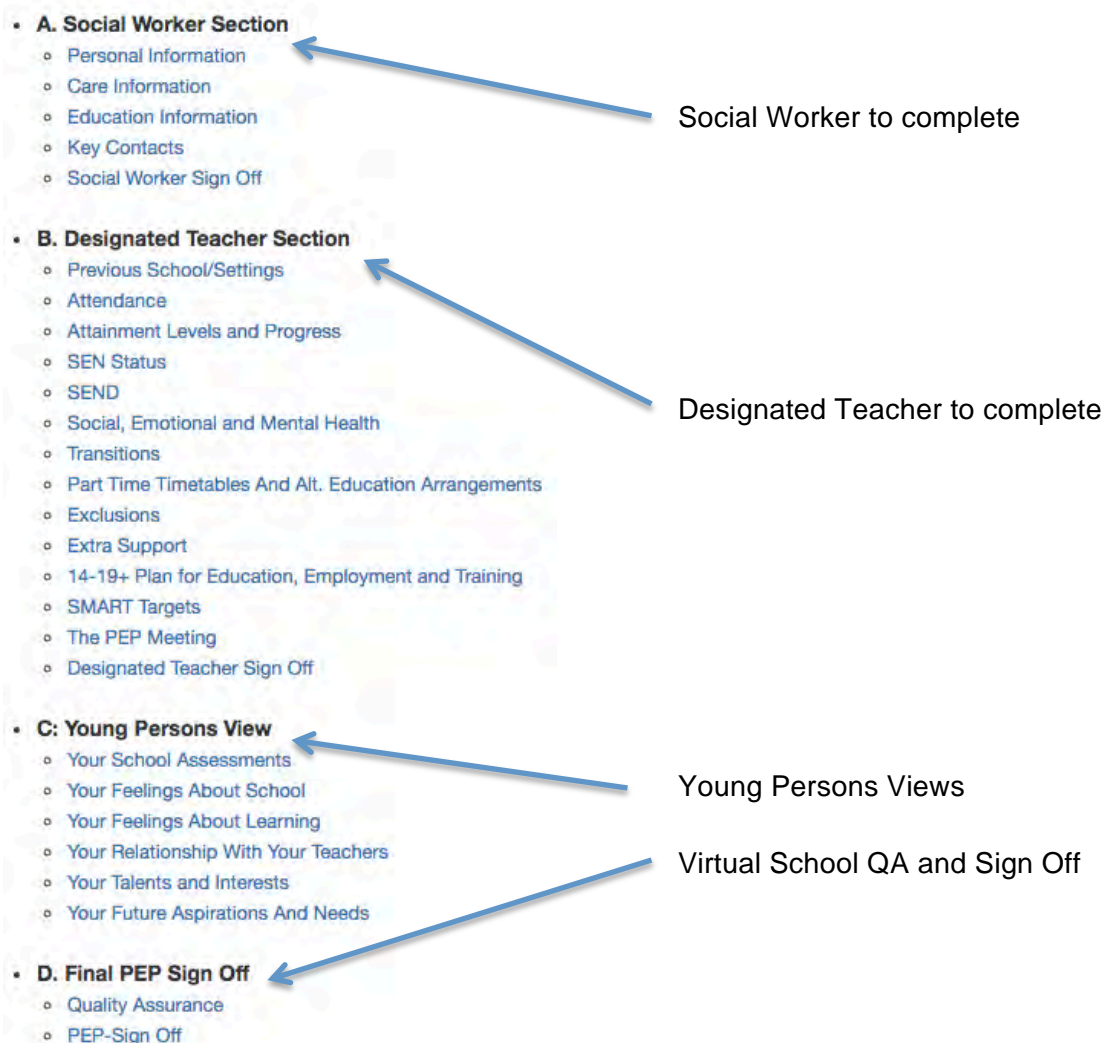
## PEP Document

When looking at the PEP document you will notice that it is split into four sections. These are:

- A. Social Worker Section
- B. Designated Teacher Section
- C. Young Persons Views
- D. Final PEP Sign Off

It is the responsibility of each user to complete as much of their section as possible **prior** to the PEP meeting. As a Social Worker, you are responsible for completing **Section A** of the PEP.

Both the Targets and PEP Meeting Page are under Section B as it should be the **Designated Teacher who chairs the PEP Meeting**. We also recommend that Targets are entered by the DT prior to the meeting but then discussed and agreed by all of those who attend the PEP.



## ***Early Years PEP***

If you are a SW for an Early Years child then you will notice some differences between the PEP forms. You access the PEP in the same way by clicking the PEP button. The layout remains the same so please complete your Section. The layout of the EY PEP can be seen here.

You will notice that for EY PEPs there isn't a Section C. We use the same format as the SEN symbols to capture EY children's views. You will find instructions on how to access this on pages 9 and 10.

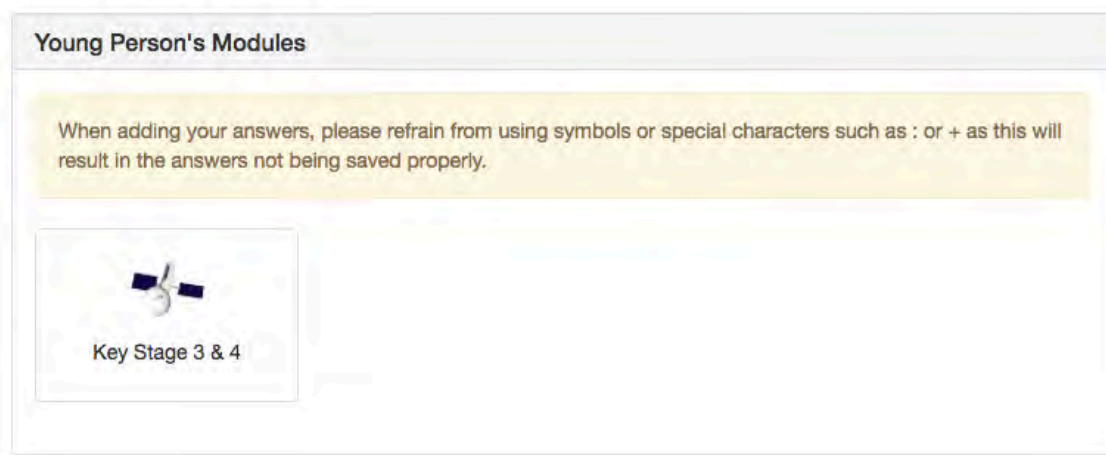
## Young Persons View Section C

There are a number of ways in which Section C can be completed. You can:

- Type directly into **Section C** of the PEP
- Use the **interactive section** which pulls the answers through into Section C
- Use the **SEN widget symbols**

If you would like to use the interactive or SEN option then please follow the instructions below.

- When you are on the PEP form you will see a blue box in the top left called **View PEP Details**. Please click this button
- You will then be taken to the PEP details page. On the right hand side you will see a box called Young Persons Modules. In there you will see either a KS 1 & 2 option or a KS 3 & 4 depending on the age of the child. Please click the button and a new tab will open



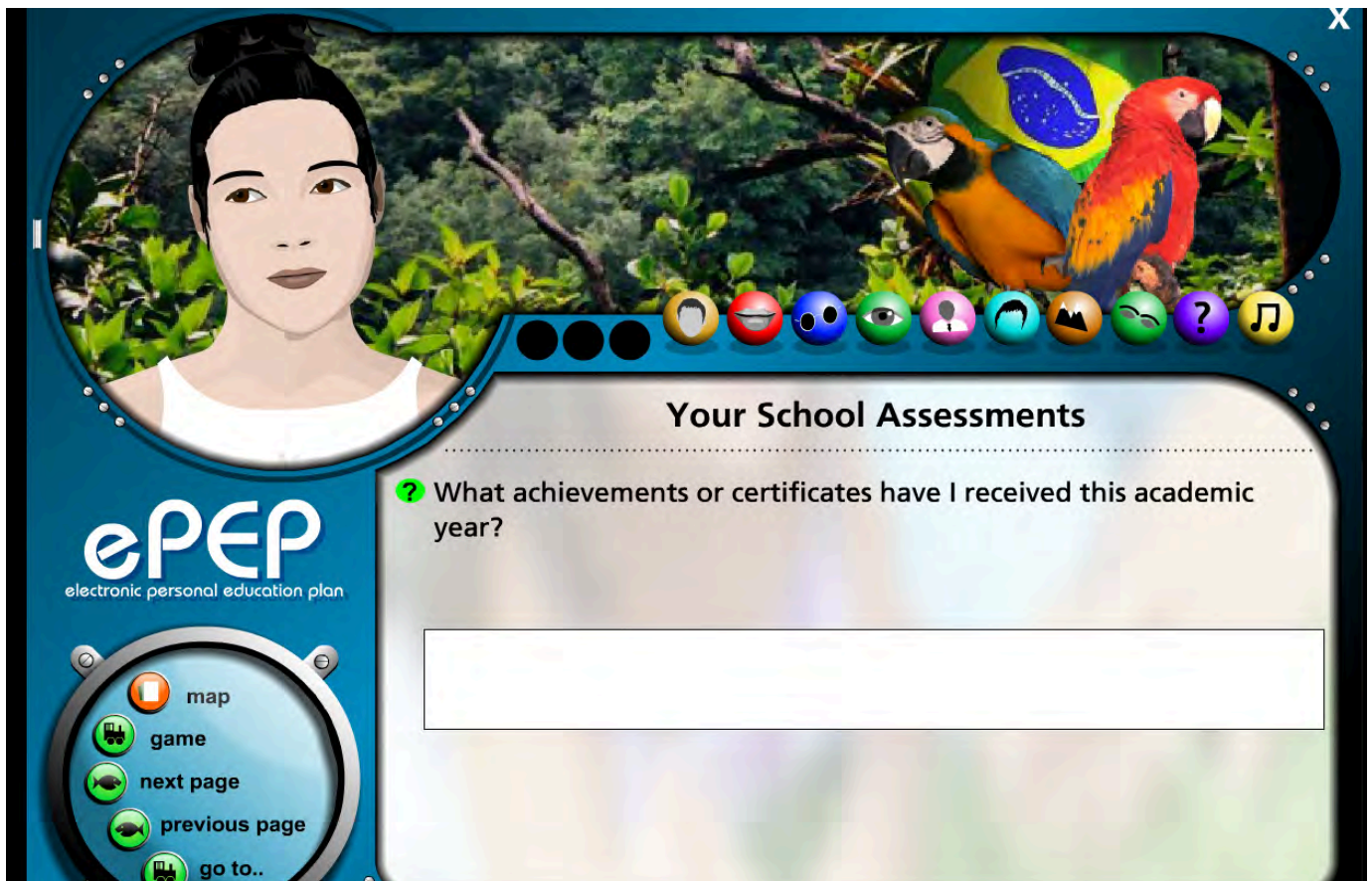
- You will then see the interactive section. Please navigate through using the tabs on the left. All answers will save automatically and pull through into Section C of the PEP



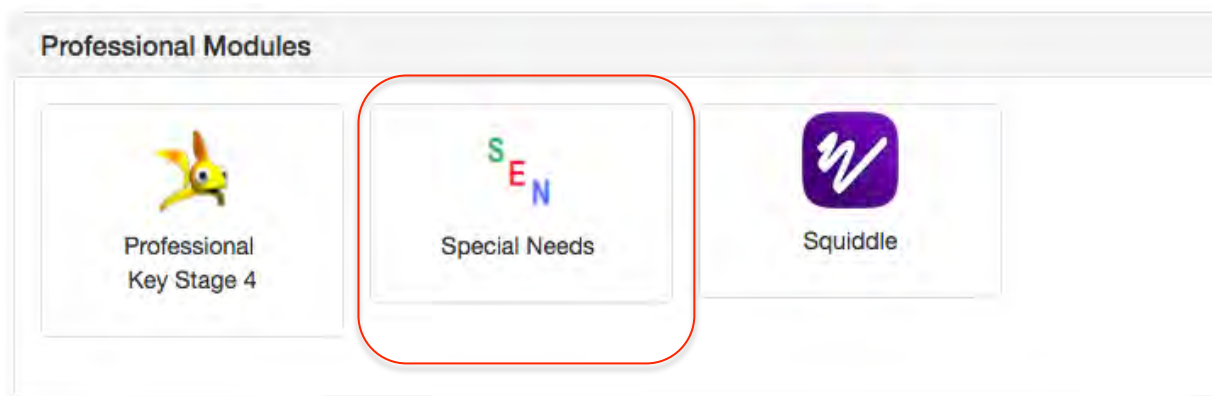
## Key Stage 1 and 2 Layout

## ***PEP Meeting***

PEP documents and PEP meetings are strongest when all concerned work in collaboration to support the child or young person and their educational progress. It is vital that a child or young person understands the purpose of the meeting and is as involved as they are able to be and that their voice is heard and appropriately acted upon. Plans are more effective when a child or young person is fully engaged in them. There is a clear link between lack of appropriate engagement of children and young people in their plans and disengagement from education. **The VS is monitoring the attendance of children and young people at PEPs and whether their views have shaped and influenced their education plan.**

Arranging the next PEP should be done as part of the PEP meeting. PEPs cannot be signed off unless a date for the next meeting has been added. The date of a PEP meeting can be changed on a current ePEP at any time by going to the current PEP meeting page and selecting the blue “HERE” button contained in the sentence “Click HERE to reschedule the CURRENT PEP Meeting”. As not all involved parties have access to the ePEP system, internal notifications via the ePEP system should not be relied upon to send invites to a PEP meeting. Social workers should ensure that those they wish to attend are sent an email invitation.

***Whoever records the PEP meeting on ePEP should ensure that they identify themselves in the box provided and press the light blue coloured button titled “Please Click here to confirm the PEP meeting has occurred”. This allows tracking of completed PEP meetings irrespective of the final PEP sign off and quality assurance by the VS.***

## ***ePEP Mandatory Fields***

The VS will have set a number of mandatory fields within the PEP document. This means that these questions must be answered in order for you to sign off your section. If you try to save a page without answering a mandatory question, the system will prompt you to answer this first.

On the PEP Sign Off page, when you press Mark Complete for your section, you will be notified of any outstanding mandatory questions. Please ensure that these are answered, as your PEP will not be signed off otherwise.

## ***PEP Sign Off***

Once your section has been completed and the PEP meeting has taken place, we ask that you go to the **Designated Teacher Sign Off Page** at the bottom of Section B. Please click the Mark Complete buttons next to the Designated Teacher and Young Person. It is very important that this is completed, as this is how the VS are notified that you have completed the PEP and it is ready to be signed off.

Once the VS have signed off the PEP you will be notified via email and the ePEP system that this has been actioned. You will also receive comments from the VS and be able to view the RAG rating of the PEP. The next PEP will automatically be generated and you can start filling that information in whenever you are ready.

## PEP Quality Assurance

Once the PEP has been submitted, the VS will then QA the PEP, give it a RAG rating and Sign Off the PEP.

You will have access to view the QA page to see the scoring from the VS. The layout of the QA page is shown below.
