

Services Available to Looked After Children Placed in Bournemouth, Christchurch and Poole (BCP) by other Local Authorities

Introduction

BCP Children's Services have produced this guidance to notify placing authorities about the resources and facilities available to any Looked After Child (LAC) who may be placed in BCP by another Local Authority.

It has been produced to inform practitioners from placing Local Authorities what services are available to looked after children and young people residing in BCP. It is also available to all Foster Carers across BCP, so they are aware of the services available.

When any social worker is planning to place a child from an outside Local Authority in Bournemouth, Christchurch and Poole they should consult with BCP as required by the 2014 amendments to the Care Planning Placement and Case Review (England) Regulations 2010.

BCP was formed as a new council on 01.04.2019 and services are integrating but there may be slight variation in services available for children dependant in which of the three towns the child is placed.

- Inform the Virtual School and LAC Nurses

Virtual School

The BCP Virtual School works closely and in partnership with schools across BCP to improve educational outcomes for looked after children and previously looked after children.

The Virtual School Team offers training to Social Workers, Foster Carers, Designated Teachers and Governors.

Personal Education Plans are coordinated through dedicated Education Officers working within the Virtual school.

Designated teachers in BCP have termly network meetings for training and sharing of good practice.

The Virtual School Head is Jeff Mason. The Virtual School Assistant Head Teachers are Kelly Twitchen and Wayne Chappell.

Looked After Children's Health Team (LACHT)

The BCP Council has a dedicated Looked After Children's Health Team who are able to support the health needs of children and young people placed in BCP by other local authorities.

Initial Health Assessments who become looked after are completed by Poole Hospital paediatricians and they can be requested by email. The LACHT team will register the child and then pass the required paperwork through to the paediatricians' administrative team for completion. The Initial Health assessment will then be arranged with the child's carer.

The LACHT team can complete Review Health Assessments for looked after children placed by other local authorities under a Service Level Agreement. These can be requested through the secure email and the LACHT will then return the SLA for agreement. Alternatively, can the placing authority can send through Name and Address for invoicing purposes.

The team can also provide some follow up health support, again subject to arranging an SLA.

Registering with a GP in BCP

The carer can register the child with a BCP GP, they will need to provide the following information:

- NHS Number;
- · Details of Previous GP;
- Letter from Social Worker confirming Placement.

CAMHS

Dorset CAMHS will only accept referrals for LAC children from their Social Workers. This is to ensure that the child receives the correct targeted service. There is an initial discussion between the social worker and the CAMHS clinician where the referral is discussed. If it is not agreed that CAMHS therapy is indicated, then there is further discussion about what might be the most appropriate and helpful course of action at that time. agreed as appropriate (or not) then a written referral will be sent in with the accompanying chronology and background information/reports. Before the work begins there will be an initial planning meeting involving the key practitioners and people involved to clarify ho the work will be taken forward.

Early Years Provision

2, 3 and 4-year-old children who are looked after will be eligible for up to 15 hours of free early education funding. 3 and 4-year-old children who are looked after are also eligible for the Early Years Pupil Premium through their own Local Authority.

Foster carers, who are in paid work outside of their fostering responsibilities, can apply for up to 30 hours extended entitlement.

Advocacy and Independent Visiting Service

The Advocacy Service for looked after children is managed by Action for Children Bournemouth, Christchurch and Poole. The service is designed to help children and young people in need of support, including children in care, participate in the decisions and

services that affect their lives by speaking up for them and promoting their rights at meetings and reviews.

Adoption and Special Guardianship

Bournemouth, Christchurch and Poole (BCP) Council and Dorset Council have delegated responsibility for most adoption and special guardianship services to Aspire Adoption. Aspire is a Regional Adoption Agency hosted by BCP Council and funded by BCP Council and Dorset Council.

Aspire is responsible for recruiting, assessing and supporting prospective adopters and matching children who have a plan for adoption with prospective adoptive families. In addition, Aspire undertakes Special Guardianship Assessments, and provides support post order for families that have been created by either adoption or special guardianship.

Youth Offending Service (YOS)

Dorset Combined Youth Offending Service works across Bournemouth, Christchurch and Poole Council and Dorset Council. The service works with young people who have received a police caution or a court order for a criminal offence. There are different professionals in the team including youth justice officers, CAMHS nurses, a speech and language therapist, a psychologist, an education officer, a careers adviser and restorative justice workers. Missing, Exploited and Trafficked Children and Young People

If a looked after child placed in the BCP area is at risk of going missing, being involved in Child Exploitation or trafficking this information must be shared with the Dorset Police Safeguarding and Referral Unit. They will need information about the placement, and details about the risks and the risk assessment and all relevant contacts. They will work with the Police Missing Persons Unit which is based at Poole Police Station and covers the whole BCP area.

Children's Services First Response Hub

The Children's First Response Hub is the single point of contact for referrals into BCP Children's Services. The Hub should be contacted if the placing social worker believes that any child in the BCP area is at risk or is being hurt or abused. In addition, the practitioner should contact the hub if they are aware of a child who may be vulnerable without additional help and support or if a family, child or young person could benefit from support services.

Out of Hours Services

The Out of Hours Service will respond to concerns where the safety and/or welfare of a child or young person is at serious risk of significant harm, and the situation cannot wait until 8:30am the next working day.

They are available Monday to Friday, from 5pm to 8:30am, all day Saturdays and Sundays, all bank holidays, including Christmas Day and New Year's Day.

Allegations Management - Local Authority Designated Officer (LADO)

The LADO is available for consultation and, when necessary, allegations management if there are concerns about an individual who works with children in the BCP area. The concern can be raised by the child placed in the area or from another source. If a concern is raised, then the placing social worker must contact the LADO. The LADO will discuss the matter with the social worker and a plan for the way forward will be agreed dependent on risk management and all known factors.
