## 4 Attachment And Bonding Advanced Level Fostering



The most important property of humankind is the capacity to form and maintain relationships. These relationships are necessary for any of us to survive, learn, work, love, and procreate. Human relationships take many forms but the most intense, most pleasurable, and most painful are those relationships with family, friends, and loved ones. Within this inner circle of intimate relationships, we are bonded to each other with "emotional glue" - we are bonded with love.

Everyone's ability to form and maintain relationships using this "emotional glue" is different. Some people seem naturally capable of loving. They form numerous intimate and caring relationships and, in doing so, get pleasure. Others are not so lucky. They feel no "pull" to form intimate relationships, find little pleasure in being with or close to others. They have less emotional glue with family and few, if any, friends.

## 12 Complex Trauma Advanced Level Fostering



The term "Complex Trauma" describes both children's exposure to multiple traumatic events - often of an invasive or interpersonal nature - and the wide-ranging long-term impact of this exposure.

These events are severe and pervasive, such as abuse or profound neglect. They usually begin early in life and can disrupt many aspects of the child's development and the very formation of a self.

Since they often occur in the context of the child's relationship with a caregiver, they interfere with the child's ability to form a secure attachment bond. Many aspects of a child's healthy physical and mental development rely on this primary source of safety and stability.

The main learning objectives of the course are as follows:

To understand complex trauma

To look at what causes complex trauma

To identify the signs of complex trauma

To look at the impact of trauma on young children

To consider the effects of complex trauma

To identify some key issues to be aware of

To identify and consider useful practices

Having an eating problem can be very hard to cope with but it's important to understand that eating problems aren't just about food. They can be about difficult things in your life and painful feelings, which you may be finding hard to express, face, or resolve. Focusing on food can be a way of disguising these problems, even from yourself.

Sexualised behaviour and experiences are part of the natural learning process of children and young people, and they express how people are beginning to identify with themselves, their own sexuality, and the influences around them.

However, this behaviour can become problematic when further issues can cause children and young people to attempt to engage other children or adults in sexual behaviours which would not be considered usual or expected at their current age.

This course provides learners with knowledge of the meaning of sexualised behaviours and the difference between healthy, problematic, and harmful behaviours. The course discusses the possible influences which may have caused these behaviours to be displayed and provides ideas for supporting and signposting children and young people who present sexualised behaviours, and their family and support teams.

To be aware of the importance of childhood sexual development

To know the pathways into sexual behaviours

To understand healthy and unhealthy sexual behaviours

To be able to work with young people with sexualised behaviour

#### 34 Young People On Remand Advanced Level Fostering
