Staff should then call 101 and tell the control room that a child is missing, that they are included in the Philomena Protocol and that a form has been sent through.

#### What happens next?

The incident will be risk assessed and a police officer will be dispatched.

The response officer should then be given part A of the Philomena form and any other relevant information including a recent photograph.

Care staff may wish to consider gaining consent for photo circulation prior to the arrival of the officer.

When the child is found an officer should speak to the child, this return interview is done to understand any harms that the young person may have been exposed to. Sometimes the young person may be more, or less, comfortable talking with staff present.

# Information for care staff



### What is the Philomena Protocol?

The protocol is an initiative to help locate and safely return a missing child.

It has been highlighted as best practice and adopted by police forces across the country, including Cleveland Police.

The protocol focuses on looked after young people that live in residential homes, but the Force is hoping to extend its reach more widely in 2021.

## What should residential home staff do?

The protocol works because information is available to all involved, which makes the process of finding the young person more efficient.

A single point of contact has been identified from the neighbourhood policing teams to help care staff understand the process and complete the necessary forms. If you need help with any part of the process, please contact your local team.



Care home staff should complete part A of the 'person at risk of missing form' and also the 'risk assessed locations' form.

These forms should be kept electronically and updated if any information changes. They are available from the Cleveland Police website www.cleveland.pnn.police.uk on the Philomena Protocol section of the front page.

Staff should establish patterns of the child's behaviour, and places the child frequently visits. They should have an up-to-date photograph and a medication list on hand.



If a child is not where they are expected to be, is late home or has gone out without permisson. The carer accepts responsibility for contacting and/or searching for the child in order to bring them home. This is the case if the circumstance and level of concern does not justify immediate police intervention.

When the child needs to be reported to police as missing, in the first instance care staff should email a copy of part B of the form to the contact management inbox. The email address is
