

What works for whom



USING YOUR PRACTITIONER SPACE/WORKER ACCOUNT:

As a practitioner you log into your account here: worker.mindofmyown.org.uk

One

Needs help but prefers the older look and feel Wants the wider range of options

Express

Has additional learning needs or is young, eg, age 2/3 upwards

Has less literacy, or English not the first language

No email account



What works for whom



USING THEIR OWN ACCOUNT:

A young person will log into their One account here: **one.mindofmyown.org.uk**

One

Able to read simple English, eg, age 7/8 upwards
Has their own email account, or is able to get one
Capable of self direction – ie, to log in, make personal choices, know who to send to without help


Express

An older young person being supported towards independence Helped by you, the practitioner, to hold a restricted account (ask your account manager if you forget how to do this)

Introduce Express

Mind Of My Own

Create a profile for the child in your practitioner space/worker account









Find a moment – "We're having sandwiches for lunch. Come and show me what you would like for afternoon snack" Capture the child's interest with the selfie and celebratory sounds

Give the child as much choice as possible and encourage them to make their own selections by clicking on the options.

Press SEND, retrieve the PDF and print it for the child to keep.

Introduce One





Show the young person the app on your practitioner account. Explain how ReciteMe works. Use the step-by-step guide to show the young person how to sign up for their own One account. Ask the young person to use the app to send you a statement about something important to them.

When you receive the statement make a point of responding straight away to the young person.



Once the young person has accessed the Website, or the App, they will need to click SIGN UP

Why we ask for this information

Choose how to read the information about your privacy:

Words with pictures

It is your right to have information about you kept private

We need you to have an email address in order to use the One app. Information given by you is sent directly to your worker (or another professional you trust). They need to reply to you securely by email. Mind Of My Own will NEVER use your email address for any other purpose. All the information you create when using the apps is stored on the Mind Of My Own servers.

We keep your email address secret from everyone except the people you choose to send your information to. We need to know your name and date of birth. This is so that when you send information to your worker, it goes to the person you have chosen to send it to. Your name and date of birth helps the Mind Of My Own coordinators to match you to the correct worker.


Mind Of My Own coordinators are workers in your organisation who are responsible for seeing private letters and reports and putting personal information (including your statements) on to your case file.


